# Public Information Report December Service

Dear ASC,

PI is doing great and we continue seeking new opportunities to serve our area. The phone line is paid up to date. Hopefully we can continue to have our phone number circulated throughout the area so more addicts can find us. One way we intend to do this is by sending PSAs (Public Service Announcements) to local radio stations. We met January 6 and discussed ways to do this. We have a few members contacting radio stations in Gadsden, Fort Payne and Rainsville, and Albertville. We also discussed contacting schools and giving presentations to the school administrators and to the students themselves in assemblies. I have a contact at the Marshall County Schools who is looking into the protocol for that for us and we have someone looking into Cherokee, Etowah, and Dekalb Counties. We decided after the initial contact with these facilities we will send letters taken from The Guide to Public Information along with IPs and meeting schedules.

I will continue to attempt to contact Carry McClung the female SAP director at the Etowah County jail to set up a presentation with the goal of starting an H&I meeting for the women there. I called December 21, 2012 and left a message with a receptionist and again on January 11, 2013 and left a voicemail. I will try again next week. (Can I schedule and give a presentation if I contact her and that is her desire before the next area?)

I have a receipt for the stamp we bought last month in the amount of \$24.83. I was given \$25.00 so I will return the unused \$0.17. Now we can use this stamp on our H&I literature and on the literature we will soon be using to place in lit racks in approved facilities.
