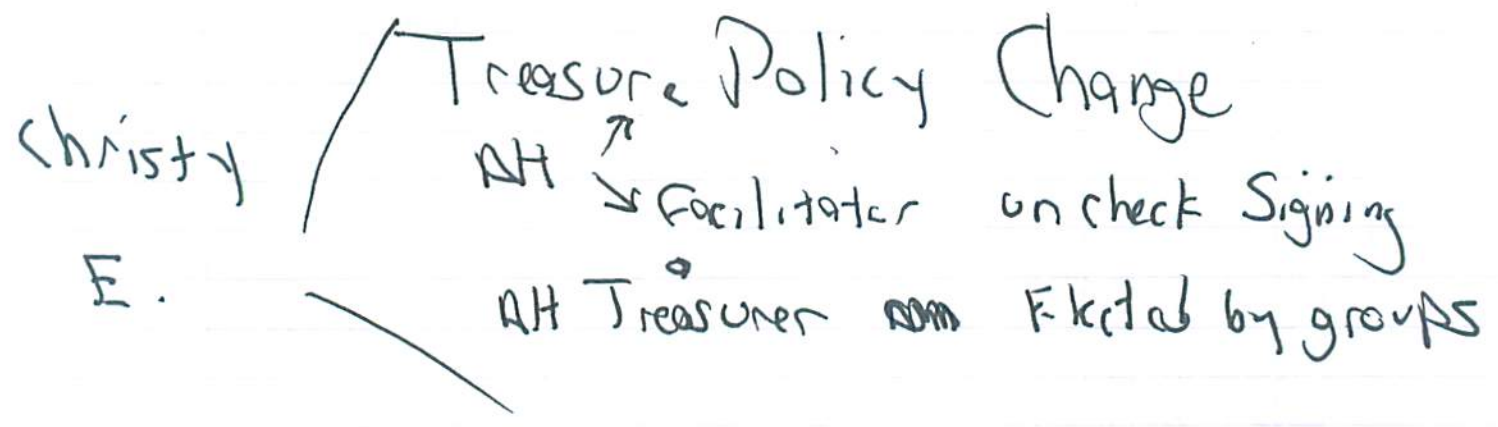

RCM REPORT 7/12/2015

Hello Family, I'm an addict named Mike. I attended the RSC on June 27 & 28, it was a great learning experience and I'm grateful for the opportunity, it has erased some of the previous beliefs I had about our Regional Service Committee. This is my first RCM report and I hope that it provides sufficient information, so that our area and the groups within knows what's going on in the Alabama/Northwest Florida Region. First thing I would like to address is that I have several flyers for events and functions in the region, if I'm expected to provide all groups an adequate amount of flyers, I will need reimbursed for ink cartridges due to the cost of replacements. The other options are I can provide each GSR and the Area Secretary with a flyer and let GSR's be responsible for the amount they think their group will need, or I can personally email each GSR the flyer, just let me know what this area wants. I also would like to everybody know that anyone who wants a copy of the regional minutes I can email that to whoever wants to receive them, just give me your email address. On Saturday morning of June 27th there was an Outreach Subcommittee meeting, during this meeting the Chair passed out maps to be filled in by each RCM that represents their area and their boundaries. There was some discussion about a virtual online s/c meeting via skype. The Outreach S/C meeting via skype will be August 23rd @ 2:00pm, I have flyers for more info.

Next up was a Welcome Workshop-Principles in the 3rd Tradition, also discussed IP#29 An Introduction to NA meetings and some discussion about how we can better welcome all members, there was a slide-show with some interesting statistics, such as what played a big part

in members staying in NA, 87% was because of Identification, 71% because of welcoming and supportive groups and 64% because of other NA members, this info can be found on NA.org.

H&I/PR Subcommittee – Chris M discussed some do's and don'ts for H&I within Alabama Prisons and recommended a PRIA orientation before entering prisons. Chris M is asking the area H&I Chairs if there's any interest in setting up booths at Conventions regarding H&I/PR

RSC discussions on Saturday, there was a nomination for Reed H as FITS V-Chair, (qualifications in minutes). Open positions for region are V. Chair, Secretary and Alt Secretary.

Sunday morning was the roundtable discussion, this is for RCM's to discuss any proposals or nominations before coming to the RSC floor, FITS is asking \$2000 to set aside for legal representation. This is not an additional \$2000 it's to be taken from the seed money and set aside and only to be used in the event they need legal representation, The reason for this is due to a threatened lawsuit in Florida, a lawyer did give some legal advice as a favor and there was no charge. The FITS committee feels this is needed so this is something to take back to the groups. Gary S and Kelly S is working on updating the Regional meeting schedules, I will be passing around a regional schedule for the GSR's to check your groups info, please correct if needed so I can get this info back to Gary. If there's any interest in a CAR workshop I need to let Harold H know in advance, the workshops can be done December through March.

John R was nominated for Region V-Chair (have qualifications) and Kelly S was nominated for Webmaster (have qualifications). PR is looking into PSA's for TV Stations.

I have a copy of the budget report for Region if anyone is interested in looking at it or I can email a copy to anyone interested. If this ASC wants to hear the numbers I can give them at this

time but just so you know it is a lengthy report. The next RSC is set for October 24th & 25th in Panama City, FL. The next RSC after that will be January 23rd & 2th and it is this ASC's responsibility to set up the arrangements, anyone with ideas and suggestions can see me or Chris M. There will be a Surrender Audit October 24th @11:00am. There was some positive sharing about the growth and camaraderie of those serving at the RSC by several members that have been a part of regional service for many years and I personally felt connected and enjoyed my time with these trusted servants. The RSC would like any input on how they can better serve and help the areas. I will be asking this ASC to reimburse me for 1 night hotel stay as I was able to split the room with another member and that member provided the gas to get there, The amount is \$99.54 and I have the receipt.



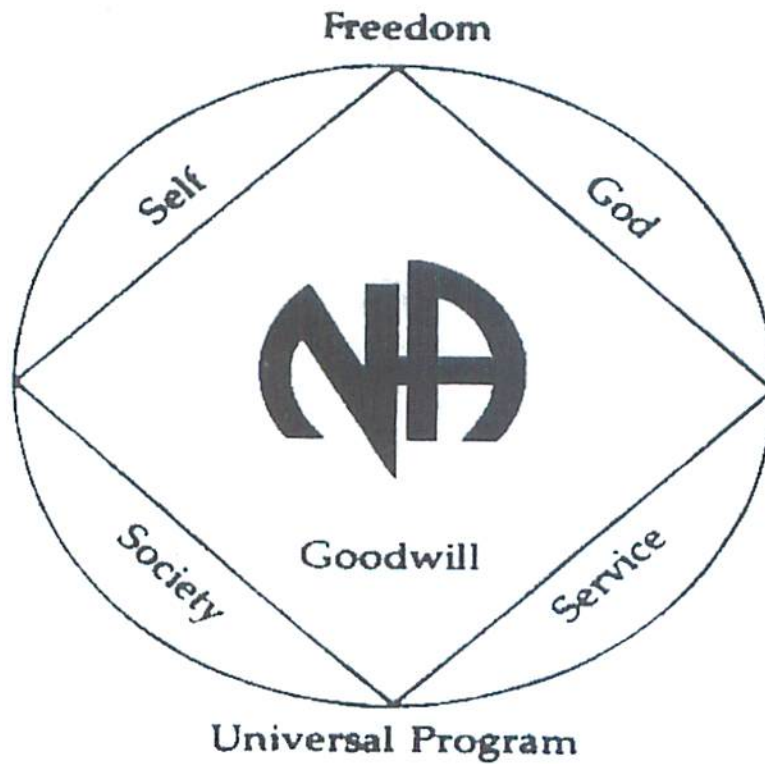

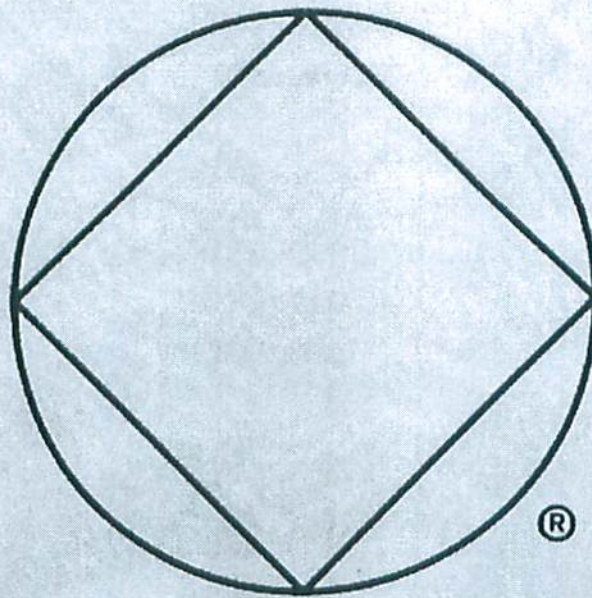
