I'm an addict named Mike. hello NEAANA. it's an ongoing privilege to serve you and the fellowship. The last RSC was on October 15" and 16" in Pensacola, FL. The first day started with the RSC Admin meeting, during the meeting I brought up our area making a proposal for Region to do an inventory, this was not received well, the Policy Chair (Michelle H) stated the Region already does a year end inventory and she would provide the information to take back to Area. The RD (Harold H) ask for input on the Southeastern Zonal Forum. GSR's talk to your groups and see how they feel about the SEZF, this is not a proposal but we would like to know how the members feel. The RD then ask "what are we doing to foster growth in the fellowship" which led to a lot of discussion and ideas, several members thought the transition from PR back to PI would help in this area. The other thing I kept hearing was we should put more effort into educating new members as to what NA is and stand up for our Traditions in a loving caring manner. Some members feel we have become soft allowing our message to become blurred. The RD then ask if we need to send a SEZF Representative to the WSC at their own expense, how do we feel about this? There was some misinformation and miscommunication about the NAWS letter issue, as you know our area voted no do not send the letter, the rest of the areas in our Region either voted yes send it or stand aside so the conscience ended up being yes send the letter. The proposal this area sent to disband the online Adobe meeting didn't pass and technically it's still just a trial basis and has not been voted into policy at this time, I voiced the concerns about some servants misusing this meeting and discussions between only one or two people after most everybody else has logged out is unacceptable. The Adobe online meeting will continue as 80% of the RCMs wanted to try and make this work. There is a proposal to purchase our own key so that Adobe is available whenever needed and it needs to be known that all subcommittees (FITS and Surrender) can use Adobe meetings and it would save a great deal of money on travel expenses. The price of the key is \$750, again GSRs take this to your groups for conscience. I aid bring up that we agreed from the start this online meeting will never be used for mation decition voting, it is only purpose is to communicate and discuss issues in nopes of

eliminating some of the long discussions that take place at the RSC. There's another proposal to raise the FITS seed fund \$2000, the FITS Chair indicated that fund raising for FITS is now limited and inflation continues to rise. GSRs take back to groups. The proposal to change PR back to PI and make PI and H&I two separate subcommittees passed. We now need a Regional PI Chair and Regional H&I Chair, announce this at groups. There's a nomination for FITS Alt Treasure, Chris A was nominated and his qualifications were supposed to be in the minutes, however I've not received the minutes and I did contact the Regional Chair last week and ask why, he indicated Michelle has some family issues going on and he will get in touch with her. I received an email from Michelle on November 8th telling me she would get the minutes out this weekend but I still haven't got them. That leads me to a concern that I've already addressed with the Region Chair, it's not Michelles responsibility to get the minutes out, we have a Vice Chair and that should be his responsibility, the Chair told me he thought V-Chair was not tech savvy and Michelle volunteered, my concern is why did we put someone in a position that can't perform the duties, the Chair said we can discuss this at next RSC. Hopefully I will get the minutes so we can read the qualifications of the nominee, this area has never elected a trusted servant without seeing qualifications and I hope we don't start now. I feel like I'm forgetting something but I've looked over my notes several times, this has been a hectic week and if I've left something out, I'll email all Admin and GSR's. I have receipts for gas and the difference in the \$200 this area advanced me, the hotel bill was \$211.86 and gas expenses was \$70.50, making the total \$82.36. I would like to remind everyone my commitment as RCM is up in June, 2017 meaning I will 2 more RSCs to attend, we need someone to step up and attend these 2 RSCs to gain the experience. 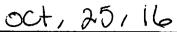
