I do appreciate you guys allowing me to contract with you as your webmaster.

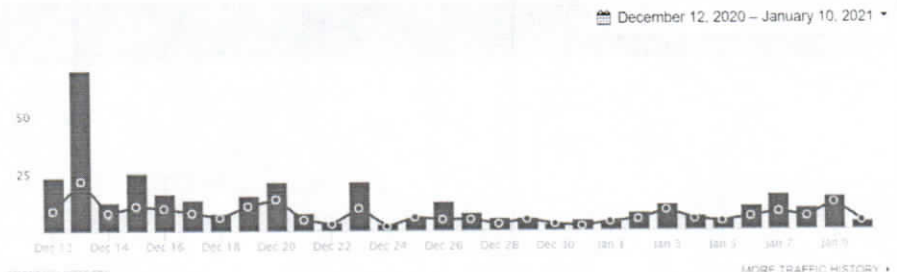
